1. That the above mentioned civil writ petition is pending adjudication before this Hon'ble court and is fixed for 26.09.2018.
2. That as per the directions given by this Hon'ble court vide order Dated 08.08.2018 passed in CWP No. 19086 of 2017 (O&M) titled, "Ravinder Singh Dhull Vs. State of Haryana and others", received through the office of Advocate General, Haryana vide Memo No. 47095 dated 20.8.2018 (**Annexure-A**) at Sr. No. 3, the Vice-Chancellor of Pt. B.D. Sharma University of Health Sciences, Rohtak constituted a Committee of three Sr. Professors/Professor from different disciplines vide Endst No. UHSR/ Rectt.&Estt./2018/7277-89 dated 24.8.2018 (**Annexure-B**), to minutely examine the testimonials including professional qualification and registration certificates of the medical and para-medical staff and submit the report to the Vice-Chancellor by 10.9.2018. The Committee comprised of Dr. Veena Singh Ghalaut (Chairperson), Sr. Prof. &



Head, Deptt. of Biochemistry, Pt. B.D. Sharma PGIMS, Rohtak, Dr. Harpreet Singh (Member), Sr. Prof. & Unit Head, Deptt. of Medicine, Pt. B.D. Sharma PGIMS, Rohtak and Dr. Anil Sharma (Member), Professor, Shri Krishna Govt. Ayurvedic College, Kurukshetra.

3. That the above committee visited the hospitals of Dera Sacha Sauda on 5.9.2018 and personally met the medical and para-medical staff produced by the hospital administration and examined the original documents pertaining to their qualifications, registration status and eligibility. The entire inspection was done under videography coverage. The Committee obtained certified copies of the documents pertaining to degrees/diplomas/registration certificates from awarding institutes/ universities/registration/regulatory bodies from the staff working in the said hospitals.



4. That the Committee submitted its initial report on 10.9.2018; however, the report of verification from the respective degree awarding Institute/University and verification report of registration status from the respective Regulatory Body/Council could be received only in respect of few members of the staff working in the said hospitals. The report was forwarded to the office of Advocate General, Haryana by personal messenger vide letter No. UHSR/VC/18/1963 dated 13.9.2018 (**Annexure-C**). It was conveyed by the Advocate General Haryana that the report needs to be placed before the Hon'ble Punjab and Haryana High Court by the University directly on the next date of hearing.

5. That thereafter, the Vice-Chancellor requested the Committee to submit the updated report in the intervening period with the current

status of verification of qualification and registration of various staff members as received upto 21st September, 2018. The Committee requested the CMO Sirsa and Head of Adhoc Governing Body of the Dera Hospitals to provide certified copies of the remaining documents as received from the Degree awarding Institute/ University/ Regulatory Body/ Council till 21st September, 2018. The Committee minutely examined all the documents and has submitted its updated report on 21st September, 2018 alongwith certified copies of verification reports from Degree Awarding Institute/University and Registering bodies and all other documents including DVD.

6. That the report submitted by the Committee alongwith the current status of verification of qualification by the Degree Awarding Institute/University and verification of registration status by the respective regulatory body and all other documents including DVD, is being submitted before this Hon'ble court along with present affidavit.
