I, the above named deponent do hereby solemnly affirm and state as  
under:-

1. That the petitioner had filed the aforesaid CWP for directing the State of Haryana to make adequate security ,especially in district Panchkula and surrounding areas in view of the impending pronouncement of judgement in a criminal trial pertaining to Baba Gurmeet Ram Rahim Singh. After hearing the same, this Hon'ble Court has been issuing directions to the State and others from time to time. Now the matter is listed for further hearing on 25.05.2018.
2. That the above captioned CWP was listed for hearing on 04.04.2018, on that day, this Hon'ble Court was pleased to issue the following directions:-

*"We are thus of the view that till the question of their legality and legitimacy re: establishment is sub judice before this Court, these institutions, in the interest of students, need to be run through an ad hoc and interim arrangement under the orders of this Court. We have in this regard heard learned Advocate General, Haryana also. It is directed that a Committee comprising (i) Deputy Commissioner, Sirsa; (ii) District Education Officer,*

**Sirsa along with two retired Principals of the Government Colleges/schools as may be nominated by the Deputy Commissioner, Sirsa on the recommendations of the DEO, Sirsa, shall constitute the ad hoc Governing Body till further orders for the purposes of running these institutes. The Dera management (DSS) is directed to withdraw, collect and disburse funds from its accounts under the written orders of the abovementioned Ad hoc Body and spend the funds for payment of salary of staff or other requirements with prior approval of the said Body. The details of the expenditure incurred on day-to-day activities of the educational institutes shall be maintained by ad hoc Governing Body and a report in this regard shall be submitted to this Court. It is clarified that this order shall not be construed to mean that this Court has recognized or accepted the validity of the educational institutes, for the arrangement made hereinabove is without prejudice to the legal rights of parties."**

3. That the present compliance report is being filed in compliance of the above mentioned directions given by this Hon'ble Court by way of an affidavit of the deponent.
4. That in compliance of the aforesaid order of Hon'ble High Court, a Committee of the following officers has been constituted by the Deponent vide order dated 08.05.2018 for the purposes of running the institution of Dera Sachha Sauda, Sirsa. The Dera management (DSS) will withdraw, collect and disburse funds from its accounts under the written order of this Ad hoc body and spend the funds for payment of salary of staff or other requirements with prior approval of the said body





**ORDER NO.: 7/77-17 PS (3)**

**DATED,- 03.05.2018**

Whereas a CWP No. 19086 of 2017 was filed by Sh. Ravinder Singh Dhull, Advocate in the Hon'ble High Court praying therein for directing the State of Haryana to make adequate security, especially in district Panchkula and surrounding areas in view of the impending pronouncement of judgement in a criminal trial pertaining to Baba Gurmeet Ram Rahim Singh. Thereafter a CM was filed by the interveners to defreeze the accounts of the institutions running by the Dera.

This case was listed for hearing on 04.04.2018, on that day, the Hon'ble High Court issued the following directions:-

*"We are thus of the view that till the question of their legality and legitimacy re: establishment is sub judice before this Court, these institutions, in the interest of students, need to be run through an ad hoc and interim arrangement under the orders of this Court. We have in this regard heard learned Advocate General, Haryana also.
